

Individual Tutoring Agreement

This agreement is made between Robin DeMarco Enterprises, Inc. a.k.a. The Skyping Science Tutor (“Tutor”), and _____, (“Client”) on the _____ day of _____, 20____, as follows:

1. Purpose

Client engage Tutor to provide academic assistance to _____ (“Student”) in the listed subject area(s)_____.

2. Performance

Tutor will meet with Student for _____ sessions per week. If the need arises, additional sessions may be arranged with Client’s consent and as the schedules of all parties permit. Tutor shall provide diligent academic assistance and expend best efforts on behalf o the child by providing individual attention and positive reinforcement.

3. Location

Tutor will perform these service online at times specified by the Client and as the parties may agree. The parties agree that the tutoring sessions will be performed via _____.

4. Session Cancellation

If a scheduled session must be canceled, Client will inform Tutor at least twenty- four (24) hours in advance. If prior notice is not given to Tutor, Client will be billed for the session in question.

5. Charges

Client will be Tutor fee of \$75.00 per session. Extra sessions shall be billed at the same rate. Partial sessions will be prorated in half-hour increments. All payments must be received a minimum of 24 hours prior to service.

Clients may sign up for automatic billing for tutoring sessions. These monthly bills are based on 4 sessions per month at a reduced rate of \$60.00 per session for a total of \$240.00 per month. This amount will be automatically deducted on the anniversary day of each month and charged directly to a credit card. In the event that the month in question has 5 tutoring dates, the extra one is free. This arrangement may be canceled with 14 days prior notice of the next billing cycle.

6. Progress
